Invitation to submit expression of interest to provide an Out of School Hour Care service at Yarralinka Primary School

Yarralinka Primary School is seeking expressions of interest from licenced providers to deliver an Out of School Hour Care (OSHC) service from the school site, commencing Term 1, 2025.

Parent and community feedback indicates that the onsite OSHC service is a highly valued service provided to the school community. It is a service that has been utilised by our families since the school opened in 2021.

Enrolments

The expected enrolment numbers for 2025 is 260 students. This is expected to grow to 320 students in 2026 and 400 students by the beginning of the 2027 school year.

Premises

A permanent classroom and playground area, including wet area and/ or canteen area for food preparation, will be available to the service provider to deliver the service.

Licence Agreement

The successful provider will be required to sign a licence (right to occupy premises) agreement with the school and will be for a period of up to two (2) years. The licence agreement will include an agreed annual licence fee which is fixed for the period of the licence and not attributed to changing enrolment numbers utilising the service. Subsequent licence agreements may see the need to relocate the service within the school, as a result of the need to access classrooms due to increased enrolments.

Process

This process is open to all interested providers. Open expressions of interest are invited in the form of a written statement and should address the following:

- Proposed hours of operation, including the likelihood of vacation care being offered;
- Fees and charges for parents;
- Annual Licence fee to be paid to the school;
- Staffing ratios and arrangements;
- Sample food menus;
- Sample programs for before and after school and vacation programs;
- Complaints policy and procedures;
- Demonstration of previous/current service delivery in similar settings;
- Brief history of the organisation (to include length of time in business, name(s) of the company principal(s) or business owner(s) and the present number of full time employees and their designations, major clients and industry expertise);
- Any other information you wish to provide to support your EOI.

After the closing date, all expressions of interest will be considered by the Principal, Manager Corporate Services, a Department of Education Commercial Services representative and a School Board representative of Yarralinka PS. From the expressions of interest, up to three providers may be requested to make a formal presentation to the Yarralinka Primary School OSHC evaluation panel. The Yarralinka Primary School OSHC evaluation panel will make the final recommendation on the selection of the provider. It is anticipated that this process will be completed by 1st August 2024.

The Yarralinka Primary School OSHC evaluation panel will undertake a value-for-money assessment to consider the extent each expression of interest satisfies the following criteria:

- (a) Suitability of the proposed outside school hours care service;
- (b) Respondent's demonstrated capacity to provide outside school hours care services;
- (c) Session fees to be incurred by parents/carers, and;
- (d) Licence fee for right to use the premises.

Expressions of interest that do not adequately address the above criteria may be excluded from further consideration.
